This <b>total requested cost may never exceed the max. available amount of 350.000 EUR</b>.</i></li></ul> <p>The overhead cost <u>should</u> be mentioned in the SBEP budget tables, but it <u>should not</u> be inserted in the national/regional FWO pre-registration form on the <a href="#">FWO E-loket</a> (see below under ‘Additional eligibility criteria’).</p>

	<p><b>The deadline to submit this administrative application to the FWO is identical to the deadline of the joint transnational call</b> (pre-proposal stage). Failure to comply with these requirements can lead to ineligibility.</p> <p>To ensure the eligibility of the proposal, it is recommended to consult the FWO administration (NCPs) at least one week in advance.</p> <p class="list-item-l1">ii) Participation in this call does not interfere with the ‘national’ FWO calls and is consequently not taken into account for calculating the max. available number of new applications and running projects combined. <b>However, researchers can only participate within 2 different international projects/consortia in this call, and only once as coordinator.</b></p> <p class="list-item-l1">iii) Projects aiming at the development of a spin-off company are not eligible in this context. 
